The following question will be asked of the Registered Voters of Madawaska Maliseet First Nation by Ballot:

"Do you approve the Madawaska Maliseet First Nation Land Code dated for reference August 22, 2017 and the Individual Agreement with Her Majesty the Queen in Right of Canada?"

AND FURTHER TAKE NOTICE that all Members of the Madawaska Maliseet First Nation, 18 years of age and older as of the date of the last official Voting Day of the **2nd day of November, 2017** are eligible to vote, **PROVIDED THAT SUCH MEMBERS MUST COMPLETE A VOTER REGISTRATION DOCUMENT TO BE PLACED ON THE LIST OF REGISTERED VOTERS.** Voter registration documents will be sent to all Eligible Voters whose address is on record with the Madawaska Maliseet First Nation. **VOTER REGISTRATION** documents are also available from **Patricia Wallace**, Ratification Officer at the website and contact information appearing below.

Please Note: Any Registered Voter may vote in person, by Mail-in Ballot or electronically. If an Eligible Voter has not received a Voter Registration Document by **October 15, 2017** please contact **Patricia Wallace**, Ratification Officer so that the necessary form can be provided to you. Eligible Voters may also obtain a Voter Registration Document at the Vote locations as indicated above.
